

**ORDINANCE NO. 0-96-03**

**AN ORDINANCE APPROVING AND ADOPTING A REVISED MASTER STREET PLAN FOR THE CITY OF ARKADELPHIA, ARKANSAS AND FOR OTHER PURPOSES**

WHEREAS, the Planning Commission for the City of Arkadelphia, Arkansas, with the assistance of the Arkansas Highway and Transportation Department and the West Central Arkansas Planning and Development District, Inc. has conducted studies regarding traffic patterns and traffic flows within the City of Arkadelphia, Arkansas; and

WHEREAS, on the basis of the aforesaid studies the Planning Commission for the City of Arkadelphia, Arkansas, has developed and proposed routes for collector streets and other modifications to the existing traffic patterns in and around the City of Arkadelphia, Arkansas; and

WHEREAS, on the basis of the said studies the Planning Commission has proposed a Revised Master Street Plan for the City of Arkadelphia, Arkansas, dated October 1995, for the City of Arkadelphia, Arkansas, and pursuant to the provisions of Arkansas Code Annotated Section 14-56-422, has conducted a public hearing upon the Master Street Plan, the same having been held on the 11th day of January, 1996, at 7:30 p.m., for purposes of receiving comments upon the proposed Master Street Plan from members of the public generally; and

WHEREAS, following the conduct of the said public hearing, the Planning Commission for the City of Arkadelphia, Arkansas, unanimously adopted the said Master Street Plan and recommended its adoption by the Board of Directors, which said Revised Master Street Plan has been certified to the Board of Directors.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE CITY OF ARKADELPHIA, ARKANSAS, TO-WIT:

Section 1. The Revised Master Street Plan, dated October 1995, titled "Arkadelphia Master Street Plan 1995-2015", final draft dated January 5, 1996, for the City of Arkadelphia, Arkansas, which is before the meeting, be, and the same is adopted and shall hereafter be the Master Street Plan for the City of Arkadelphia, Arkansas. The Master Street Plan consists of 47 pages, including 9 maps or figures and a table as well as a cover sheet and table of contents.



Section 3. The Master Street Plan adopted January 9, 1958, in Ordinance 155 is hereby repealed in its entirety.
