

ORDINANCE NO. 0-98-__11

AN ORDINANCE PROVIDING FOR THE CREATION OF THE ARKADELPHIA MUNICIPAL AIRPORT ADVISORY COMMITTEE, REPEALING ORDINANCE NO. 149, AND FOR OTHER PURPOSES.

WHEREAS, the City of Arkadelphia created the Arkadelphia Municipal Airport Commission by Ordinance 149, which Commission is governed by the Acts of 1949, No. 53, as may have been amended from time to time, and

WHEREAS, the Arkadelphia Municipal Airport is presently being operated by Henderson State University in connection with their aviation program, and **THEREFORE**,

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE CITY OF ARKADELPHIA, ARKANSAS:

SECTION 1 - There is hereby created a Committee to be known as the Arkadelphia Airport Advisory Committee to be composed of six members who shall be residents and qualified electors of the City of Arkadelphia.

SECTION 2 - Five of the committee members shall be nominated by the City Manager and confirmed by a vote of the duly elected and qualified members of the City Board of Directors. One of said committee members shall be nominated by the President of Henderson State University and confirmed by a vote of the duly elected and qualified members of the City Board of Directors.

SECTION 3 - The committee member nominated by the President of Henderson State University shall serve an indeterminate term subject to the will of the Board of Directors and the President of HSU. The remaining committee members shall serve staggered five-year terms. A committee member may succeed himself/herself. Present Commission members shall continue to serve their terms on the Advisory Committee.

SECTION 4 - Committee members shall receive no compensation for their services but shall be entitled to reimbursement for expenses reasonably incurred by them in the performance of their duties as members of said committee.

SECTION 5 - The Airport Committee shall be advisory in nature and shall make recommendations to the City Manager and the City Board of Directors concerning operation of the airport.


SECTION 6 - The committee shall elect from its members a chairman and vice-chairman and shall determine their tenure as such officials. It may also appoint a secretary who may be but is not required to be a member of the Committee.

SECTION 7 - The said committee shall hold regular meetings. In addition, the Chairman of the committee may call special meetings. The Chairman shall also set the agenda for the advisory committee.

SECTION 8 - If any section or provision of this Ordinance shall be held invalid for any reason, it is hereby declared the intention of the City Board that such holding of partial invalidity shall not render the remaining sections and provisions invalid.


SECTION 9 - It is the intent of this Ordinance to repeal Ordinance No. 149, which was enacted under the provisions of Act 53 of 1949 and to hereafter operate the airport under Act 135 of 1929 and Act 175 of 1959, known respectively as ACA §14-360-101, et al. and ACA §14-360-301, et al., all as may be amended from time to time.
